#### Directions to Scott's...

<u>From the San Francisco, Oakland, and Berkeley Areas</u>: Take the I-80 (across the bridge if applicable to Walnut Creek) Hwy 24 exit. Take Hwy 24 through the Caldecott Tunnel. At the 24/I-680 interchange, stay in the middle right lane. Take the Mt. Diablo exit, and make a left on Bonanza. Turn right into Complimentary Valet Parking Garage.

<u>From the San Jose, Livermore, and San Ramon Area</u>: Take I-680 North to Walnut Creek and exit on South Main Street. Follow South Main Street to Newell and turn left. Make a right onto California Boulevard. Follow California to Bonanza and turn left onto Bonanza. Turn right into the Complimentary Valet Parking Garage.

<u>From the Vallejo, Benicia, Martinez, and Concord Areas</u>: Take I-680 South to Walnut Creek. Take the North Main Street exit and turn right onto North Main. Follow North Main Street, which becomes California Boulevard (veers to the right). Turn right onto Bonanza, then left into the Complimentary Valet Parking Garage.
